



## 24-48 Hour Perfect Fit Pet Agreement

We/I the undersigned agree that while \_\_\_\_\_, a \_\_\_\_\_ is in our care, for the purpose of deciding if this animal will be a perfect fit for our family, we will be entirely responsible for her/his/their care 24/7.

- Feeding at about 7AM and 6PM with the food provided. Directions will be given.
- Walks and potty breaks: morning when dog first awakes, after breakfast, Mid-Day, before and after dinner, and before bedtime – every day. One supplied Treat may be given before bedtime.
- Cats and Kittens must have a clean Litter Box with Dr. Elsey's Cat Litter, scooped daily.
- At no time is the animal allowed other foods or liquids, except clean water. Our animals may not have any People Food except un-spiced skinless boiled or broiled turkey, salmon, lean beef, cooked green beans, cooked or raw carrots.

### **CMR will provide for your use:**

Food and Water bowls, Toy(s), Bed, Crate, (dog)Nylabone, Collar with attached microchip tag (if available) and a Leash. If needed a Litterbox filled with Dr. Elsey's Cat Litter

Water must be made available from 7:00AM – 8:00PM daily during this time.

### **During this Perfect Fit Experiment this ANIMAL may NOT:**

- be off leash outside of your home at anytime, for any reason.
- go to any Dog or Human Park or Recreation or Public Park area
- interact with any other animal(s), other than those in your home that we met during your Home Visit.

### **YOU MUST IMMEDIATELY NOTIFY US 813-507-0509 of the following:**

- **Should the animal for any reason run away or become lost: You must immediately begin searching for the animal as it does not know your area, does not know your scents, or your neighborhood.**
- **Time is of the essence in finding a Rescue animal while they are in an unfamiliar area.**
- **Rescues animals will bolt and be in grave danger instantly. Our Critters are NOT Street savvy.**

- Should this animal get injured and/or should the dog injure any other dog or human, for ANY reason while in your care, you are agreeing to be fully responsible for any and all Veterinarian bills and medications to bring the dog back to being whole.
- **Should this animal become ill for any reason:** Our Veterinarian or an Emergency Vet will decide on the cause and treatment plan for each animal.
- If our Veterinarian or ER Vet believes the animal became ill or injured while in your care, due to chance or negligence or exposure on your part, you are agreeing to be fully responsible for any and all Vet bills.

- Flea and Heartworm Prevention is to be given on the 15<sup>th</sup> of every month.
