We/I the undersigned agree that while _____, a Female/Male, Canine/Feline, other _____, who's Breed is _____, Color(s) _____, age or DOB _____, Chip # _____ is in our care, for the purpose of deciding if this animal will be a perfect fit for our family, we will be entirely responsible for her/his care.

- Feedings at about 7AM and 6PM - food will be provided with instructions.
- Canines need Walks and Potty Breaks: morning when first awakes, after breakfast, Mid-Day, before and after dinner, and before bedtime – every day. One supplied Treat may be given before bedtime.
- At no time is the Animal allowed other foods or liquids, except clean water. Absolutely NO People Food except cooked green beans, cooked or raw carrots for Treats.
- Felines must have clean, fresh water 24/7 and eat ONLY our supplied kibble, canned foods and/or treats.
- Canines must have clean fresh water Morning thru 8PM and eat ONLY our supplied kibble, canned foods and treats.

CMR will provide for your use:

Food and Water bowls, Toy(s), Canine Nylabone, Collar and/or Harness with attached CMR Tag and if available a microchip tag and a Leash. Animal will arrive in a plastic Carrier or a metal Crate. All of the above is on loan, to be returned at the end of this trial.

During this Perfect Fit Trial this Animal may NOT:

- be off leash outside of your home at anytime, for any reason.
- go to any Dog Park or walk outside of your immediate yard.
- interact with any other animal(s), other than those in your home that we met during your Home Visit.

YOU MUST IMMEDIATELY NOTIFY US 813-507-0509 of the following:

- **Should the Animal for any reason run away or become lost:** You must immediately begin searching for them. The Animal doesn't know your area, does not know your scents, or your neighborhood. Time is of the essence in finding a Rescue Animal while they are in an unfamiliar area. Rescues are known to bolt and will be in grave danger instantly. Our Critters are NOT street savvy at all.

- **Should the Animal become ill for any reason:** Our Veterinarian will decide on the cause and treatment for each Animal. If the Veterinarian believes the Animal became ill while in your care, due to chance or negligence or exposure on your part, then you are agreeing to be fully responsible for any and all Vet bills.
